



## Solar Opportunities for Owners Through Illinois Solar for All

Last Updated: June 13, 2023

Are you a homeowner or the owner of a single-family building or a two-to-four-unit building? You may be eligible to save money on your electricity costs.

Illinois Solar for All (ILSFA), an income-qualified state program, allows you to install a solar system on your roof or in your yard with no upfront costs and low or no monthly fees. Single-family homeowners who participated in Illinois Solar for All have saved an average of more than \$1,000 annually on electric bills. Individual savings will vary. Each home and offer is different, and you can learn your expected savings by requesting a “standard disclosure.”

Consider this offer, and call the approved solar company, known as Approved Vendors, for a specific quote for your home. Be sure to request the company’s ILSFA offer. Participants must be income-eligible and receive an electricity bill. Visit the ILSFA website to [determine your income eligibility](#).

## Solar Company’s Residential Solar (Small) Offers

A solar company in the Illinois Solar for All (ILSFA) program has made the following residential solar standardized offer available for eligible Residential Solar (Small) program participants. This offer is available to standard systems of up to 10 kW in size. Individual offers may vary based on site considerations.

<sup>2</sup> A Power Purchase Agreement charges fees based on the production of the solar project, a lease charges set monthly fees, while a purchase charges a flat amount. Regardless of the offer type, the solar company may not include charges that exceed 50% of the value of the energy savings from the solar project.

<sup>3</sup> Note, offer rates may not be representative of the offer’s total cost, as additional fees could apply. More detailed information about an offer will be provided on the Standard Disclosure form that the solar company is required to provide to you as part of an offer. Solar companies may present participants with the Standard Disclosure Form and installation contract in the same interaction and both documents can be executed contemporaneously. The participant has the right to cancel within fourteen calendar days of executing the contract at no cost.
