So Illinois solar for all, also known as ILSFA, was made possible originally through the passage of the future Energy JOBS Act, and was updated recently at the end of 2022 with the new requirements and additional budget from CJOB.

The program works through state and utility funding, which provide incentives to solar companies by buying renewable energy credits to help make solar installations and income eligible and environmental justice communities more affordable, which also helps the state meet its clean energy goals.

Along with those incentives, comment requirements for savings and consumer protections.

ILSFA is available to income eligible residents, which includes homeowners and renters, as well as nonprofits and public facilities that serve income eligible communities.

So the solar companies must register with the Illinois shines and ILSFA programs and at Elevate for ILSFA carefully. That's each company that works with the program. They must also follow the Consumer Protection handbook, which outlines how the program prioritizes and takes care of other residents it serves.

Elevate also reviews all projects to make sure they follow the requirements and that the benefits reach the participants and those benefits to participants can be seen directly on their bills or indirectly.

Income eligible households are defined as those whose income do not go above 80% of the area median income, so this eligibility does vary by county and the number of people living in the household on the ILSFA website, there is an income lookup tool where you can find the maximum income for different counties and household sizes.

So first, the homeowner or a building owner picks an approved vendor or AV who drives the process. the AV starts to plan the solar project, they determine site suitability and either the AV or the program administrator conduct the income verification. And once they have completed verification and eligibility, the AV submits the project for review and approval by the program administrator who checks program requirements and those consumer protections.

Once it is approved, the AV starts with the installation of the solar system and finally, once the system is connected to the electricity grid, the resident can start to create renewable solar energy and start saving money.

Their first subprogram is the residential solar, with either the small subprogram one to four unit households, or the large 5 plus unit household subprogram. The households must be income eligible, and it is possible for households rented to participate where the homeowner signs the contracts and the tenants must be income eligible, and there are also site suitability requirements for the homes, which are listed here.

The next sub program is Community Solar, which allows members of a community to subscribe to a single solar system. That system is installed at a site served by your local electrical utility. Anyone with an electricity account with that utility can subscribe to shares of that system. Then your electricity supplier will credit the electricity accounts of all subscribers based.

The nonprofits and public facilities Subprogram is our 4th subprogram. It installs on site solar projects on properties that are considered critical service providers in an income eligible and or environmental justice community that provides engagement to that community.
