## Purpose

Illinois Solar for All (ILSFA) brings the benefits of solar energy to income-eligible communities through its Residential Solar (Small and Large), Non-Profit and Public Facilities, and Community Solar sub-programs. Illinois Solar for All offers this **Energy Resources Guide for Residential Buildings and Non-Profit Facilities** to provide information on programs and services to improve building energy performance, affordability, tenant comfort, health, and safety. This includes energy efficiency programs, bill payment programs, health and safety programs, and building improvement programs.

Programs are organized by service offering and include a description, eligibility requirements, applicable property categories, and relevant website(s) to find more information.

*Note: Most of the programs and resources listed here are only available in a specified geographic area (e.g., city, town, county, utility service territory, neighborhood, rural area) and type of customer or demographic (e.g., residential, income-eligible, senior citizen). Interested parties should confirm eligibility criteria, status, available funding, and applicability of the programs listed directly with the administrators of the identified programs and services.*

# Multifamily Energy Efficiency Programs

The following programs can assist building owners with energy efficiency upgrades. Some programs can assist in remediating health and safety issues that need addressing before energy efficiency upgrades can proceed.

## Multi-Family Energy Savings

Multi-Family Energy Savings offers property owners opportunities to save money and energy at their multifamily properties. Serving properties in the ComEd, Nicor Gas, Peoples Gas, and North Shore Gas territories, the offering provides free products and incentives for energy efficiency improvements. Energy-saving products and services include ENERGY STAR® certified LEDs, boiler replacements, air conditioners, weatherization improvements, and more.

**Eligibility requirements:** Three or more unit multifamily properties; located in ComEd, Nicor Gas, Peoples Gas, or North Shore Gas territories.

## Ameren Illinois Multifamily Energy Efficiency Incentives

**Eligibility requirements:** Income requirements; three or more unit multifamily properties; property must be serviced by Ameren Illinois.

## Ameren Illinois Public Housing Authority Incentives

Ameren Illinois program staff are available to provide technical and financial assistance to Public Housing Authorities (PHAs) to improve tenant comfort, manage usage, and reduce costs. PHAs are eligible to receive incentives for energy efficiency upgrades for projects that service income-eligible

residents. Ameren Illinois can help PHAs develop plans at the start of a project to maximize eligible incentives to help improve residents' comfort, manage usage, and reduce costs.

**Eligibility requirements:** Limited to Public Housing Authorities within Ameren Illinois territory; additional occupancy and compliance requirements.

Free home energy assessments may include weatherization services and installation of energy-saving products to help increase comfort, lower utility bills, add value, and extend the life of your home.

**Eligibility requirements:** Income requirements; single-family home or two-flat building; home was built at least 30 years ago; owner-occupied (if applying for a two-flat building, both units must be inhabited)

and the building owner must occupy one unit); located in Cook County; not a previous Energy Savers Program participant.

## H.O.M.E. (Housing Opportunities & Maintenance for the Elderly)

This program helps Chicago's income-eligible senior homeowners maintain their independence by providing services including home upkeep and repair; a "shopping bus" to assist seniors who have limited mobility or live in areas with little access to fresh food; affordable housing; and a moving program offering support and assistance when moving to a new home.

**Eligibility requirements:** 62 years of age or older (55 or older if disabled); live south of North Avenue within the City of Chicago; have no more than \$1,200/month in income (income/mortgage ratio is considered).

## Illinois Energy Efficiency Loan Program

## Illinois Home Weatherization Assistance Program (IHWAP)

The Illinois Home Weatherization Assistance Program provides weatherization services for income-eligible residents and households to reduce energy costs and make homes more energy efficient. This is done through various improvements, including insulation and air sealing. Services are performed at no cost to qualified applicants, depending on the program.

**Eligibility requirements:** Illinois residents; the household's combined income must be at or below 150% of the federal poverty level using State funds and 200% of the federal poverty level using DOE and HHS funding.

## Small Accessible Repairs for Seniors (SARFS)

*\*Currently closed, may reopen waiting list in 2024.*

The Small Accessible Repairs for Seniors (SARFS) program provides safety, security, and accessibility improvements that help senior citizens to remain in their homes. Repair types are limited to minor repairs that may include (but are not limited to) grab bars, lever faucets, door repairs, carbon monoxide detectors, smoke detectors, and wheelchair ramps.

**Eligibility requirements:** Chicago seniors who earn no more than 80% of the AMI and are at least 60 years of age. Qualified recipients may be owners or renters residing in a one- to four-unit building. Renters must have permission from the landlord, and the landlord needs to certify that they will not increase the rent due to SARFS improvements.

Participation in Power Smart Pricing does not guarantee savings over the standard fixed-price rate, and individual savings will vary from month to month based on usage and market conditions.

## Affordable Connectivity Program

The Affordable Connectivity Program helps ensure households can afford the broadband they need for work, school, healthcare, and more. The benefit provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal Lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price. The Affordable Connectivity Program is limited to one monthly service discount and one device discount per household.

**Eligibility requirements:** A household is eligible if a member of the household meets at least one of these criteria [listed here](#).

The Public Schools Carbon-Free Assessment program provides facility assessments to identify opportunities to save energy, electrify facilities, and reduce overall carbon usage. Once assessments are complete, ComEd will help customers access energy efficiency incentives and plan additional decarbonization projects.

## Single-Family Housing Repair Loans and Grants

Also known as the Section 504 Home Repair program, this program provides loans to income-eligible homeowners to repair, improve, or modernize their homes or grants to elderly income-eligible homeowners to remove health and safety hazards. The maximum loan is \$40,000; the maximum grant is \$10,000; and loans and grants can be combined for up to \$50,000 in assistance.

**Eligibility requirements:** Income requirements; owner-occupied; be unable to obtain affordable credit elsewhere; have a household income that does not exceed the [very low limit](#) by county; must be age 62 or older for grants.

## City of Chicago Home Repair Program (HRP)

Previously known as the City of Chicago Roof and Porch Repair Program, the Home Repair Program (HRP) provides grants to income-eligible homeowners for improvements to their roof or porch. In 2024, the program is only open to residents who own and occupy a 1-to-2-unit residential property and who earn up to 50% of the Area Median Income (AMI). This must be your primary and only residence.

## City of Chicago Emergency Heating Repair Program

\*This program is open from November 1, 2023 to April 1, 2024.

The City of Chicago Emergency Heating Repair Program is a first-come, first-served grant program for emergency repair or replacement of faulty or inoperable residential heating systems during the winter season.

**Eligibility requirements:** Income requirements; owner-occupied home; must be on deed for one year prior to application; habitable; not at risk of foreclosure; located in Chicago; all utilities must be current and in working order; must maintain ownership and occupancy for one year or pay back prorated amount of funds.
