

How to Determine if Electricity Customer Receives Competitive or Non-Competitive Service

Updated November 2024

This determines whether the customer receives a utility rebate for Distributed Generation and energy storage at a rate of \$250/kW or kWh or \$300/kW or kWh.

Ameren

Check the customer's Ameren electricity bill to determine their *electric delivery class*. This is shown under the "Electric Delivery" heading.




DS-1 and DS-2 customers are **<u>non-competitive</u>** and receive utility rebates at the \$300/kW or kWh rate.

DS-3 and DS-4 customers are <u>competitive</u> and receive utility rebates at the \$250/kW or kWh rate.

ComEd

Check the customer's ComEd bill to determine their customer class or customer group. This can be found above the customer's name/address on the first page, or under "Charge Details" on the second page.



The following customer classes/groups are **<u>non-competitive</u>** and receive the utility rebate at the \$300/kW or kWh rate:

- Residential (including "Single" or "Multiple," with or without space heat, and with or without a designation of "Hourly")
- Watt-hour Non-Electric Space Heating
- Demand Non-Electric Space Heating (0-100 kW)
- Nonresidential Electric Space Heating (<100 kW)

All other customer classes/groups are **<u>competitive</u>** and receive the utility rebate at the \$250/kW or kWh rate.
